He is also a respected mentor and advisor to many young foresters in Michigan. Hunter Fodor, ACF, who nominated Smalligan, credits him as a "crucial resource in my professional development and success" and notes his instrumental guidance in planning Michigan's 2025 State Chapter Meeting.

"It's truly an honor to receive this recognition from ACF," said Smalligan. "I've always believed that public and private foresters working together lead to the best outcomes for our forests, our communities, and our profession."
